Third-party Cookies, on the other hand, come from different domains than the one you are on. They are often used in online ads and can track your browsing across various sites.

4. COOKIES WE USE

We employ various types of cookies to ensure smooth website operation, improve your user experience, and support targeted advertising. Below is an overview of the cookies we use and their functions:

• Essential Cookies (Strictly Necessary Cookies)

These cookies are crucial for essential website functions. They are necessary for the site's operation and do not require your consent. Essential cookies enable secure logins, maintain sessions, ensure site security, and detect fraud and other risks. They facilitate key functions like access to secure areas and e-commerce transactions.

• Non-Essential Cookies

_ga	Performance	Employed by Google Analytics to differentiate between individual users, track user interactions, and gather statistical data for analytical reports.	24 months
_ga_V786SJDMMB	Performance	Used by Google Analytics to track user behavior and interactions, enabling detailed analytics and performance optimization specific to website sections.	24 months
